- Social Security cards, a Social Security number verification letter, or other U.S. government verification document for all persons you may list on the return. (birth certificates, school records, legal filings, lease, etc.)
- Birth dates for all persons listed on return.
- Copies of last year's federal and state returns, if you have them.
- All income statements: Forms W-2 and 1099, Social Security, Unemployment and other statements such as pensions, stocks, interest and any documents showing taxes withheld.
- If you own or run a business or farm, collect records of all your income.
- All records of expenses, such as tuition, mortgage interest, or real estate taxes.
- If you own or run a business or farm, collect records of all your expenses.
- All information reporting forms such as the 1095-A, 1095-B or 1095-C.
- Bank routing numbers and account numbers to direct deposit any refund.
- Dependent child-care information: name and address of paid caretakers, business EIN, caretaker's social security number or other tax identification number.
